STIPULATION AND [PROPOSED] ORDER MODIFYING NOTICE DATE IN THE AUGUST 3, 2018 ORDER
REGARDING CLASS NOTICE, CLASS NOTICE PROCEDURE AND SELECTION OF ADMINISTRATOR

1 WHEREAS, on July 26, 2018, the Court directed the parties to submit agreed-to changes to the
2 Notice of Class Action in this case;

3 WHEREAS, on July 30, 2018, the parties submitted agreed-to changes to the Notice;

4 WHEREAS, on August 3, 2018, the Court entered the Order Regarding Class Notice, Class
5 Notice Procedure and Selection of Administrator (the "Order") and sent it to counsel, but counsel for
6 plaintiffs did not receive the Order until August 9, 2018;

7 WHEREAS, the Order provides that the administrator transmit the Postcard Notice to brokers
8 and nominees, mail the Postcard Notice and publish the press release over *Business Wire* "[w]ithin ten
9 calendar days after the entry of this order" (referred to in the Order as the "Notice Date");

10 WHEREAS, due to the delay in receipt of the Order, the Administrator cannot prepare, mail and
11 publish the materials by Monday, August 13, 2018; and

12 WHEREAS, Class Counsel asks that the Court extend the Notice Date from Monday,
13 August 13, 2018 to Friday, August 24, 2018;

14 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED among the parties,
15 through their respective counsel, to the entry of an order providing that paragraphs 2 through 4 of the
16 August 3, 2018 Order be modified as follows:

17 2. On or before August 24, 2018, the Notice Administrator shall send copies of the
18 "Postcard Notice" to brokers and nominees on the Notice Administrator's list of brokers and nominees
19 that commonly hold securities for the benefit of investors, as well as any other persons or entities
20 identified on the list of all persons who purchased or otherwise acquired Apigee Corporation ("Apigee")
21 common stock between April 24, 2015 and March 16, 2016 (the "Transfer List"). Said brokers and
22 nominees shall be instructed to identify for the Notice Administrator, within ten calendar days of their
23 receipt of the Postcard Notice, all beneficial owners who meet the definition of the Class ("Beneficial
24 Owners List"). In the alternative, brokers and nominees may forward the Postcard Notice to all those
25 identified on the Beneficial Owners List.

26 3. On or before August 24, 2018, the Notice Administrator shall send by USPS First Class
27 Mail the Postcard Notice to each purchaser or beneficial owner identified on the Beneficial Owners List


1 (the "Notice Date") and shall cause the full-length Notice of Pendency of Class Action ("Notice"),
2 relevant Court documents, procedural posture and frequently asked questions and answers to be posted
3 to the case website.

4 4. On or before August 24, 2018, the Notice Administrator shall cause the contents of the
5 Postcard Notice to be published on one occasion in a press release over *Business Wire*, a national
6 newswire service. The Notice Administrator shall also take reasonable measures, including online
7 targeted advertising, as described in the Vasquez Declaration, to maximize the number of relevant
8 visitors to the case website. Class Counsel shall cause the full-length Notice, as well as a link to the
9 case website, to be available on its website, www.rgrdlaw.com.


